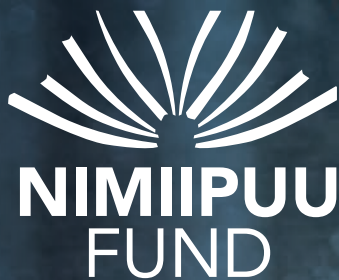

A MESSAGE FROM THE EXECUTIVE DIRECTOR

Greetings! As we welcome 2023, we acknowledge the ongoing recovery of the pandemic for our business owners, community members, and that we have deep impacts from 2020. From shuttered businesses, increasing costs of living, or loss of loved ones, we at Nimiipuu Fund have adjusted to provide support along the way. I think of resilience when I consider what everyone has gone through and also adaptation, yet remaining strong in our cultural values and traditions in taking care of each other.

Nimiipuu Fund continues to support capital to deploy services. 2022 marked a year to plan for new growth with research, development, and strategy. We thank you for participating in our studies related to market needs, business needs, and the feasibility of developing a business incubator space. Creating ecosystems to economic development was also developed with our championing the development of Universal Commercial Code with the Nez Perce Tribe. A long overdue process to reduce barriers to businesses in Indian Country which included lack of access to capital or uncertainty in investing on Tribal lands/reservations. Commercial codes govern many aspects of business transactions and our Tribe has the same right to establish laws to govern commerce/business within their jurisdictions. We aim to finalize this code by 2023.

Our organization is celebrating its ten (10) year anniversary in 2023. As our landmark event we plan on further developing our CDFI loan fund with expansion of loan products and services. Our strategic goals from 2023-2026 include areas of growth and deployment of

new loan products in the areas of housing - home improvement and rehabilitation, expanded business loans, and providing services to help launch these new products along with our mainstays of financial education and coaching. Our staff and board reviewed our research and developed methods to meet the needs of our market and develop our CDFI.

Our landmark celebration was held at our Nimiipuu Fund Nation Building Conference (March 28-30, 2023) at the Clearwater River Casino. This collaborative celebration included our federal, state, and regional partners who support capacity building for our entrepreneurs. Other events included hosting Nimiipuu Fund's first Business Pitch and Fashion Show. Our entrepreneurs rode the wave of the pandemic and now with high costs of doing business, we are providing resources to support. This cannot be done without an amazing team - George Moody, Natasha Edwards, and Heewekse Wisdom and volunteers.

At this time in history, we have an opportunity to lay the groundwork for our ecosystem to achieve economic prosperity. What does this mean? It means funding opportunities and our strategies are lining up to capitalize our fund to grow our team and develop resources to meet the needs to leverage this capital to create jobs, housing, business development and build assets. Our goal is to continue to reach our vision of "A better financial life by advancing individual self-determination and self-sufficiency for every community member." I am confident in our ability to meet our mission and vision by our work with each client to ensure their success.

WHERE WE WORK

Nimiipuu Fund was established in 2013 by the Nez Perce Tribe to foster economic growth for the Nez Perce reservation and traditional areas of Idaho, Oregon, and Washington. By providing access to capital, financial, and entrepreneurial capacity building we create economic opportunities, advance entrepreneurial spirit, and preserve cultural values.

The Nimiipuu, or Nez Perce Tribe, held a large land base in the Pacific Northwest while traveling with seasons from buffalo hunting in the Great Plains to salmon fishing at Celilo Falls. 17 million acres in what is now Idaho, Oregon, Washington and Montana made up the Tribe's homeland. Today, the Nez Perce Indian Reservation consists of 750,000 acres, of which the Tribe or Tribal members own 13 percent. The Tribe, with an enrolled membership of about 3,500 (2011), is headquartered in Lapwai, Idaho. The land and natural resources management continues to be paramount for the Nez Perce.

BUSINESS INCUBATOR

Entrepreneurs and small business owners have always required resources, knowledge, and access to markets. In metropolitan areas these essentials tend to be easier to come by but in rural areas office space, broadband internet, and capital are limited, let alone the equally important relational aspects of coaching, mentorship and community support. Native American communities face an additional hurdle, the private-enterprise system is usually weak and connections with markets outside the Reservation are under-developed.

The resiliency of local communities and economies was put to the test during the COVID-19 pandemic, as lock downs created a variety of hardships for small and locally operated businesses. One positive outcome from this was that the Nimiipuu Fund discovered just how many entrepreneurs existed within the Nez Perce Tribal community. The hardship created an opportunity to build bridges with and between these small business owners, many of whom were operating fairly isolated “micro-businesses” out of their own homes.

Springing from this revelation was the Nimiipuu Fund’s concept of a Business Incubator, which could serve as the home for economic growth within the Tribal community. The incubator concept could provide an array of benefits including office space, retail space, artists co-op/gallery space, conference rooms, co-working space, business coaching, affordable training programs, and space for community and cultural events. Beyond all this, the incubator would also tighten social and economic bonds leading to stronger cultural preservation among Tribal members.

Points Consulting, in partnership with Nimiipuu Community Development Fund, developed and presented a Business Incubator Feasibility Report to the Nez Perce Tribe in 2022. Nez Perce Tribe and community members provided feedback, interviews, and conversations concerning this project with open and honest responses. This data was collected and included in the report which consummates seven months of thorough socioeconomic research, evaluation, best practices, and community engagement on behalf of Points Consulting project team. During this process, the project’s Steering Committee supplied valuable guidance, information, and coordination with community and Tribal members.

Participants universally supported to establish the Business Incubator to continue Nimiipuu Fund operations creating an environment for small business, entrepreneurs, and the community to come together. Many members wish to see successful businesses become more visible in their community and encourage small business development. Discussions on entrepreneurship also connects the desires for those in entry to mid-level careers to stay in the local area rather than moving to metro areas for work opportunities. To be successful, the Incubator will require persistent and patient leadership on behalf of Nimiipuu Fund and other leaders within the Nez Perce community. Nimiipuu Fund must raise the necessary funds to support the development of the Incubator building and programming. At the same time, leadership must guide those with commercial interests to see themselves as entrepreneurs, and to invest the time and energy required to grow their businesses.

FINANCING CHANGE

NATIVE CDFI SEED CAPITAL AWARD

Rooted in Native culture and history, Native community development financial institutions (CDFIs) provide access to fair, affordable funding in Indian Country, where mainstream finance does not traditionally reach. Three Native CDFIs — Akiptan, Haa Yakaawu, and Nimiipuu Fund — were honored by Opportunity Finance Network (OFN), Oweesta Corporation, and Wells Fargo with the 2022 Native CDFI Awards.

Native CDFIs open avenues for economic opportunity through innovative financial products, advanced capacity building efforts, and deep relationships with their respective Tribal communities,” said Chrystel Cornelius, president and CEO of Oweesta Corporation. “It is an honor to recognize these native CDFIs who are reaching deep into their communities to finance change.”

Nimiipuu Fund was recognized with a Seed Award, given to an emerging Native CDFI with a strategy showing exciting potential for success and impact. Nimiipuu Fund promotes economic growth, while embracing the cultural values of the Nez Perce Reservation and surrounding communities. With the \$75,000 grant, the CDFI will launch a home rehabilitation lending product to meet the need for quality affordable housing.

“This award will allow us to expand our current suite of loan products to address what our community needs,” said Jonelle Yearout, executive director of Nimiipuu Fund. “Our CDFI is working to improve the housing stock and quality of life on the reservation.”

With determination and steadfast commitment, they seek creative and innovative ways to meet the capital needs of their people,” said Beth Lipson, interim president and CEO of OFN. “This year’s award recipients are leading the way and creating real change for Indian Country, and I offer them my most sincere congratulations.”

PATHWAYS TO NATIVE BUSINESS OWNERSHIP

Nimiipuu Fund hosted many events and hands-on workshops in 2022 with the focus on the Native journey into business with certified Northwest Native Development Fund Indianpreneurship and First Peoples Fund trainer and business coach, Roxanne Best (Confederated Tribes of the Colville Reservation).

From photography practices for business, stress management tools for a practical way to improve productivity and reduce time spent spiraling through yoga, Indianpreneurship for entrepreneurs, business coaching, and photography workshops, Best has helped Native business owners learn how to best represent and expand their brand.

Our workshop business coaching focuses on mindful business marketing strategies while brainstorming ways to accomplish set goals. Native business owners utilized session and incorporated business marketing with our partner, Unleashed Marketing + Design, working to get individuals on track to making their business goals come true.

In 2022, Nimiipuu Fund hosted three Native Artist Popup Shop events focused on supporting our local entrepreneurs by providing market space for their products and services.

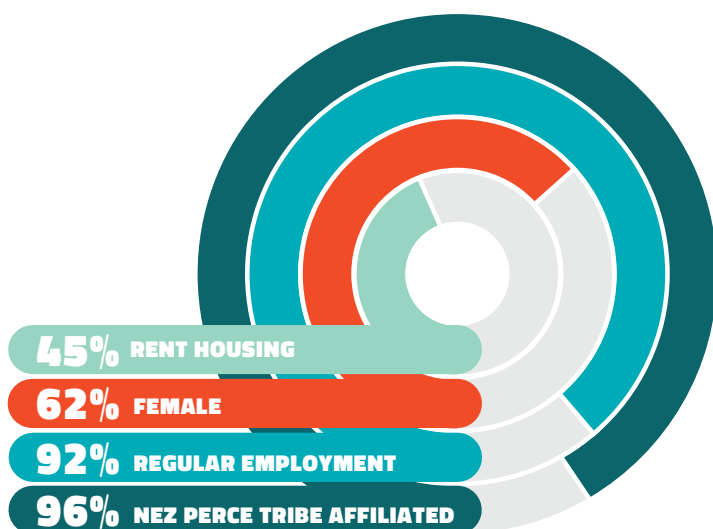
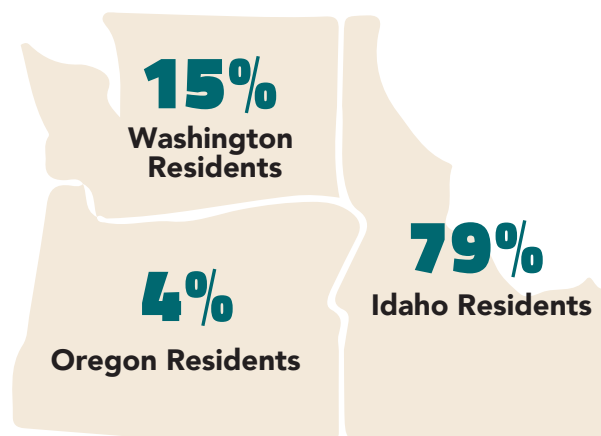

RESPONDING TO CONSUMER NEEDS

Impact Data: A Community Snapshot by Oweesta Corporation for Nimiipuu Fund, 2016-2022

2022 embarked another year of finding unique ways to respond to consumer interest and needs. The results and top recommendations from the survey included a mixed response to access to capital with a concern over credit scores, predatory lenders and pandemic impacts. Participants showed an entrepreneurial desire to start a business with the need for business environment support and expanded business services. Uniquely, we discovered the need for housing and home repair on the rise along with the desire for a local bank credit union and youth and elder financial education. Our clients come from our home state of Idaho and reached across the United States from coast to coast.



CLIENT DEMOGRAPHICS

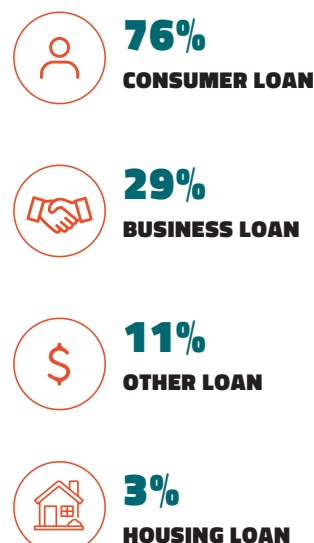
